2026 Annual Dues Billing

SURVIVING SPOUSE LIAISON – Jackie Kohler:

There will be a **Surviving Spouse Recognition** for Diane Womack Boyer, Laura Wesely and Nan Dewey at the **October** Dinner.

Parity for Surviving Spouses: Increase Dependency and Indemnity Compensation (DIC) - a benefit for survivors of those who die in service or from service-connected conditions lags other federal survivor benefits. DIC provides only 43% of what a 100% service-disabled veteran receives. Civilian federal survivor programs provide up to 55% of the employee's calculated retirement pay. This inequity leaves military

survivors with less support than their civilian counterparts, despite the sacrifices their loved ones made in service to our country. Here is the progress: The Caring for Survivors Act of 2025 (S. 611/H.R. 2055) has been introduced in both the Senate and the House of Representatives. The Senate bill, S. 611, was introduced on February 18, 2025, and referred to the Committee on Veterans' Affairs. The House bill, H.R. 2055, was introduced on March 11, 2025, and referred to the House Committee on Veterans' Affairs. A subcommittee hearing was held on June 24, 2025. Currently, both bills are in the committee stage. Please write to your Senators and Congressmen to support this effort. It is imperative that everyone not only those affected by the passage of this bill continue to engage with their Senators and Congressmen/women to lend support to this very worthy cause. Government Shutdown: Healthcare will not be interrupted, but some ancillary services such as counseling and transition assistance are on hold.

As you may be aware, funding for some government agencies, including portions of the Department of Veterans Affairs, expired at midnight this morning.

President Trump opposes a lapse in appropriations, and on September 19, the House of Representatives passed, with the Trump Administration's support, a clean continuing resolution to fund the government through November 21. Unfortunately, Democrats are blocking this Continuing Resolution in the U.S. Senate due to unrelated policy demands.

During the current lapse in funding, the vast majority of VA benefits and services will continue uninterrupted, but the government shutdown is not without consequences to VA. Here is what you need to know:

The following critical Veterans care and assistance programs will be impacted by the government shutdown:

- VA will not provide Veteran career counseling or transition assistance program activities.
- The GI Bill Hotline will be closed.
- VA regional benefits offices will be closed.
- VA will cease public affairs and outreach to Veterans.
- VA will not permanently place headstones or maintain the grounds at VA national cemeteries.
- VA will not process applications for pre-need burials.
- VA will not print new presidential memorial certificates.

Thankfully, the government shutdown will not impact the following VA services:

- Veteran health care is not impacted. VA Medical Centers, Outpatient Clinics, and Vet Centers will be open.
- VA benefits will continue to be processed and delivered, including compensation, pension, education, and housing benefits.
- Burials will continue at VA national cemeteries. Applications for headstones, markers, and burial benefits processing will continue.
- The Board of Veterans' Appeals will continue decisions on Veterans' cases.
- VA Contact Centers (1-800-MyVA411) and the Veterans Crisis Line (Dial 988, Press 1) are open 24/7.

North Carolina Priorities for the Military!

- 1. Secure and increase funding for the North Carolina Scholarship for Children of Wartime Veterans (Wartime Scholarship). Reward/Impact: By strengthening this scholarship program, we honor the sacrifices of North Carolina's veterans while investing in the educational success of their children. Expanding and protecting this funding provides stability for military families, promotes higher education, and ensures dependents have the opportunities their parents fought to defend.
- 2. The establishment of Veterans Treatment Courts in ALL North Carolina counties and jurisdictions, coupled with increased funding to adequately support Veterans Suicide Prevention programs at the local community level. Reward/Impact: This ensures that every veteran across the state has equal access to justice, rehabilitation, and lifesaving resources. By expanding treatment courts and suicide prevention funding, North Carolina will reduce recidivism, save taxpayer dollars, strengthen families, and most importantly—save veterans' lives.
- 3. Expand property tax relief for North Carolina veterans. Reward/Impact: Providing greater property tax exemptions ensures financial stability for disabled veterans allowing them to remain in their homes and communities. This measure reduces economic hardship, honors military service and sacrifice, and demonstrates North Carolina's commitment to supporting veterans and their families long after service. Adjustments & Samp; Improvements to NC Property Tax language and exclusions.
- 4. **Update statutory language to reflect current 38 CFR guidance for Veterans and surviving spouses.** This technical change to the NC General Statutes—along with updated eligibility requirements on the NCDVA Form 9—is urgently needed. (NO COST). Reward/Impact: Many surviving spouses across North Carolina are negatively impacted because state law does not align with current VA Dependency & Samp; Indemnity Compensation (DIC) eligibilities. Additionally, the current \$45,000 property tax exclusion for 100% disabled veterans fails to reflect today's economic realities and excludes veterans with significant—but less than 100%—disability ratings.
- 5. Advance HB 288 POW/MIA Flag/State Bldgs. & Schools. Reward/Impact: Passing HB 746 ensures that North Carolina visibly honors those still unaccounted for, reinforces public awareness of the sacrifices made by service members and their families, and demonstrates the state's unwavering commitment to the principle of leaving no one behind.
- 6. Expand support and resources for veterans and dependents affected by toxic exposure. Strengthen state-level programs to address the long-term health impacts of toxic exposure (such as burn pits, Agent Orange, and contaminated water). Ensure that dependents also have access to screenings, healthcare resources, and financial relief when impacted by a veteran's service-connected exposure. Reward/Impact: By addressing toxic exposure comprehensively, North Carolina can close critical gaps in care, reduce long-term health costs, and honor its obligation to veterans and their families. This investment saves lives, supports dependents who often bear hidden burdens, and demonstrates leadership in safeguarding the health of future generations.

MOAA Announces New Medicare Advantage Partnership

To help Medicare-eligible MOAA members have access to Medicare information and options available to them, MOAA is partnering with Veterans Healthcare (VHC) to provide access to Medicare Advantage plans designed for veterans. VHC is a veterans-focused organization that can walk members through Medicare options and share how Medicare Advantage plans can provide enhancements to traditional Medicare – such as dental and hearing benefits – as well as the potential for a partial Medicare Part B reimbursement.
